FORM OF INDEMNITY TO BE SIGNED WHEN CHECKING INTO THE RETREAT

I/We, the various persons listed below (hereinafter referred to as "we"), have read and understood this form.

Reference to Eingedi Retreat includes the operator and/or its members and/or directors and/or employees and/or agents and/or suppliers and/or the various operators associated with, contracted to or providing services on or to Eingedi Retreat.

- Eingedi Retreat reserves the right of admission.
- By signing this form, we accept the conditions of residence and personal liability for all amounts arising from or due to my/our residence.
We are aware of the facilities and activities provided at Eingedi Retreat, as well as the risks, which we have been made aware of. By my/our signature we accept the terms of the indemnity, and as such we agree to be bound by the following:
 - We will be held responsible for any damage or loss caused to the property by my/our acts or omissions, default, accident or neglect. By booking with Eingedi Retreat, we agree to indemnify and to pay on demand, an amount reasonably required by Eingedi Retreat to make good or rectify such damage or loss caused by me/us or any person under my/our gaurdianship. Normal wear and tear is excluded.
 - We, the undersigned - individually and on behalf of the members of my/our party for whom we are legally responsible (including, but not limited to, my children, and those in my care, guardianship or custody) - agree to indemnify and hold harmless Eingedi Retreat from and against all costs, losses, claims, demands, suits, actions, payments and judgments, including legal and attorney fees, arising from personal or bodily injuries, property damage or otherwise, however caused, brought against Eingedi Retreat, that may arise for any reason from or during the undersigned's use/occupancy of the facilities, equipment or vehicles at Eingedi Retreat.

3. PERSONAL UNDERTAKING

- We are aware of, and accept, that we and members of my/our party, for whom we are legally responsible, may be exposed to a variety of risks and dangers at Eingedi Retreat, and/or associated directly or indirectly with the use of accommodation and facilities, and participation in optional activities offered by the Eingedi Retreat.
- We realise, that depending on the activities we chose to participate in, this may require of me/us to be in a good physical and mental condition, and we warrant that we are in such a condition.
- We agree at all times to obey, whether in the retreat area or participating in any activity, any warning notices and instructions of the Eingedi Retreat and/or the operators, their management and/or the person in charge of the activity. They may, in their sole discretion, decide to cancel, terminate or curtail any activity at any stage for whatever reason as they deem fit.
- We undertake, upon occupation, to read the House Rules placed in all the units, and to familiarise ourselves with the information on the facilities, activities and services available at Eingedi Retreat.
